# 1. Apologies for absence

Apologies were received from Cllrs G Smith, G Gooderson, J Maiden and D Harrington.

## 2. Public Question Time

Mr D Jones said he was still awaiting a reply to an email he sent to the Mayor on 4<sup>th</sup> February. The Mayor thought no reply was necessary.

# 3. <u>Co-Option of Councillor</u>

There were no persons standing for co-option.

#### 4. Police Liaison Officer

Sgt Bane gave the following report compiled up to 16<sup>th</sup> April 2015 from 20<sup>th</sup> March 2015: We have recorded 27 offences during this period which is an increase of 9 crimes for the same time a year previously.

This variance appears to be as result of an increase of Theft offences this year.

# Burglary.

This is a domestic related incident and the suspect is a family member.

## **Burglary Other than Dwelling.**

5 Incidences of burglary have occurred, two relate to a local Hotel where guests rooms have been entered and bank cards solely taken and money removed from accounts. And during one night 3 business premises in the town centre were entered where money and charity boxes were taken.

#### Violent Crime.

3 Common Assaults, two are domestic related involving parents and children, the third relates to a male who has refused to provide any details of the incident apart from he was assaulted. We have also received a non-recent rape allegation by the then partner from 20 years ago.

**Criminal Damage.** There have been four counts of criminal damage, 1 is connected to a local home where the offender has been arrested. Another one was as a result of an ill family member, another was a sign damaged on a gate. The final one relates to an ongoing problematic neighbour where a fence slat was damaged and offender arrested and remanded before the court.

#### Theft.

We have had 12 counts of theft. One theft from shops, offender was arrested and charged.

Another where we had 1 reported theft from motor vehicle on Cliff Top Car Park where handbag was taken after the window had been smashed.

She said she had enjoyed the past 8 years and had learned a lesson that when people work together they achieve a lot more, this was shown with Anglia in Bloom. ## 14. <u>Civic Society/Mark Service</u>

Consideration was given to a contribution of £250 to the Civic Society for an award for Mark Service for the contribution he has made towards the historical events of the town.

A lengthy debate ensued regarding this matter.

**RESOLVED** (9 for, 3 abstentions) no contribution be awarded.

#### 15. Gas/Electricity Prices

As deferred from the April Finance meeting, consideration was given to the new quotes from Every Aspect for gas and electricity supplies from Opus Energy. Quotes were available at the meeting.

**RESOLVED** (11 for, 1 against) accept the quote and enter into a one year contract with Opus Energy.
